

## **TERMS OF USE**

Last updated on: January, 2026

These Terms of Use (“TOS”) apply to your use of the ClearMate - Photo Clean (“App” or “Service”). However, it does not apply to any third-party websites linked to the App.

The terms "we," "our," and "us" refer to VoyageBay Limited, and the terms "you," "your," and "user" refer to you as a user of the App. You and our rights and obligations regarding the use of the App are outlined below.

By visiting or using the App, you agree to be bound by this TOS and consent to the provisions or terms as described below. If you do not agree with these terms or provisions, please do not use the App.

### **■ AGE**
